The risk of injury from the activities of SJBMF is significant, including the potential for damage, injury, permanent disability, and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF SJBMF, or others acting on its behalf, and assume full responsibility for my participation.
2. I willingly agree to comply with the stated and customary terms and conditions for participation in SJB activities. I will respect the property of SJBMF, its volunteers, guests, and affiliates. If the participant is a minor, I warrant that I am a legal parent and/or guardian of such minor, and I expressly consent to the minor participating in the event/activity with SJBMF. I further agree that all of the terms contained herein apply to the minor in addition to myself and on behalf of my heirs, executors, administrators, successors, assigns, and next of kin. Should a minor for whom I sign this Agreement, in the sole and absolute discretion of SJBMF, require emergency treatment, I consent to SJBMF authorizing such emergency treatment and further agree to full financial responsibility for any such emergency medical treatment.

I, for myself and on behalf of my heirs, executors, administrators, successors, assigns, and next of kin, HEREBY RELEASE AND HOLD HARMLESS SJBMF, and each of its officers, directors, officials, agents, attorneys, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and/or any other affiliated organization or official (collectively, the "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law.
4. If any provision of this Agreement shall be declared invalid for any reason whatsoever, then notwithstanding any and all such decree(s) of invalidity, all of the remaining terms and provisions of this Agreement shall remain in full force and effect in the same manner as if the invalid provision had not been contained herein.

BY SIGNING BELOW, I ATTEST THAT I HAVE READ THIS VOLUNTEER WAIVER AND RELEASE AGREEMENT, FULLY UNDERSTAND EACH OF ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT OR DURESS.
